MINUTES OF PARISH COUNCIL MEETING HELD ON MONDAY 18th SEPTEMBER 2017 AT 7.30 p.m. AT BIERTON SPORTS CENTRE

Present: Cllr. B. Robson in the chair, Cllr G. Sherley, Cllr J Batson, Cllr S. Cotton, Cllr B. Dewis, Cllr A. Webber and the Clerk Mrs. M. Smith in attendance.

1. Apologies for Absence : Cllr J. Gilpin, Cllr M. Grieves, District Councillor Julie Ward,

2. Declarations of Interest in Items on the Agenda:

No interests were declared

3. Minutes of the Last Meeting:

The minutes of the Parish Council meeting held on the Monday 17th July were accepted as a true record and duly signed.

4. Open Public Forum

The members of the public were interested in making their views known to the Parish Council about a number of Planning Applications including:-

- 17/03316/APP Land to West of Gib Lane A number of residents wished to voice their opposition to this application to build 95 houses. The main points raised were regarding coalescence due to the proposed reduction in space between the village and the Kingsbrook Development, the increase in traffic and the number of houses proposed on a site of approximately four acres.
- 17/02587/APP Cane End Lane One resident of Rowsham Road asked the Parish Council to support
 this application which proposed to develop a site the present state of which, according to the resident, is
 an eye sore as the area has become a dumping ground for building waste & rubbish. He believed
 therefore that the development of the site is welcome but raised a concern about whether
 accommodation would be needed on the site.
- 16/04113/APP 106 Aylesbury Road One resident queried why the Parish Council had not objected to this application which related to the conversion of the existing dwelling into two dwellings. The chairman explained that the Parish Council could only comment on a planning application on certain criteria relating to building regulations. The Parish Council has three options, support, object or no comment. If there is not a basis to object or support an application then the Parish Council will offer No Objections and in this particular case the Parish Council did state that the Parish Council did not object to the application as long as proposed dwellings respect the Conservation Area. The Parish Council has had further discussions as the building work has proceeded with the District Councillor who has advised that the building still meets with the application as approved.

5. Parish Council Vacancy

Three candidates had expressed an interest in the vacancy for the parish councillor, Lorna Fisher, Alison Jones and James Wallace. The chairman asked each candidate to give a brief introduction about themselves, the reasons they wished to become a Parish Councillor and the experiences that they could bring to the role. The Parish Councillors were given voting slips by the clerk and asked to put a cross next to one name. The votes were counted by the clerk in the presence of one of the members of the public.

The majority of votes were in favour of Lorna Fisher. Lorna Fisher then signed the Declaration of Acceptance of Office which was then duly signed by the clerk.

The chairman then invited Cllr Fisher to join the Parish Council.

6. Clerks Report – The Clerk's report was noted.

County Councillor Bill Chapple arrived at 8.05 p.m.

7. Planning Applications

The following applications were considered:-

17/03002/APP 93a Aylesbury Road HP22 5BT - Part two storey and part first floor front extension - **No Objections**

17/02587/APP Os 5270 Cane End Lane Bierton - Change of use of land into dog care business and horse livery and stud - The Parish Council agreed that the site is unsightly at present and this proposal would mean that the site would be cleaned up and hopefully the business would become profitable. However concern was raised

about the proposal to keep rare breeds and also the increase in traffic along Cane End Lane and Hulcott Cross Roads that this development would generate. The Parish Council agreed to SUPPORT this application as long as the application remained a small scale proposal and did not become overdeveloped to attract large visitor numbers.

17/03316/APP Land to West of Gib Lane, Bierton - Erection of 95 dwellings including access, landscaping and associated infrastructure. Also to discuss possible projects for off-site sport/leisure contribution.

The Parish Council considered that this application would be a significant overdevelopment of the site. The Parish Council also commented that the application did not show how the access from the site would relate to the road junction to be built leading to the Kingsbrook development. This point was raised at the Community Event and no answer was given.

It was decided that the Parish Council would OBJECT to the application and that Cllr Sherley would look at the Transport implications and Cllr Robson would concentrate on the Design and Access statement. Draft comments would be prepared and circulated to the other councillors before submission to AVDC.

Cllr Sherley will also work with the clerk to put in a S106 proposal for the off-site sport/leisure contribution.

17/02588/APP 2 Burcott Lane, HP22 5AU - Conversion of barn into three dwellings - The Parish Council stated that the application appeared to be an overdevelopment of the site although the plans on the AVDC website were not very clear. The Parish Council also queried whether the proposal was within the rules of the Conservation Area and also whether it would impact on the listed building, Redberry Farm. Cllr Cotton would look at the details and would put forward a response to be agreed with the other councillors before being submitted to AVDC.

17/02147/APP Part Os 108 Burcott Lane, Bierton - Retention of three mobile stables and feed store situated on concrete base - The Parish Council had NO OBJECTIONS in principle but it was noted that this is a retrospective application and that the stables had already been erected with apparently no comeback.

8. Planning Determinations

17/02566/APP Badricks Farm 94 Aylesbury Road HP22 5DL - Erection of dwelling with integral garage - Refused

9. Other Planning Matters

a) Kingsbrook, Land East of Aylesbury, Broughton Crossing -

The design of the traffic lights to be installed on the A418 had still to be approved by Bucks County Council. It is hoped that a stakeholders meeting would be arranged to discuss this and other issues.

b) Vale of Aylesbury Local Plan (VALP) -

A final version of the Vale of Aylesbury Local Plan (VALP) has been published online in advance of the VALP scrutiny meeting on Tuesday 26 September. Cabinet will consider the plan on Tuesday 10th October and Council on Wednesday 18th October.

A public consultation will run from Thursday 2th November to Thursday 14th December. Comments made at this stage will be sent to the examiner who can make amendments to the plan.

It was noted that Bierton with Broughton is classified as a medium village with sufficient amenities to sustain development but does not have any additional housing allocation in the VALP to be included in the 27,400 new homes figure . Policies S2(Spatial Strategy for Growth) and S3 (Settlement Hierarchy and Cohesive Development) both contain statements that would apply to the query regarding coalescence around Bierton. Cllr Robson asked the other councillors for their input to the response to the consultation to be submitted from the Parish Council.

c) Bierton Crematorium -

There had been no update on the start of building works.

d) Aylesbury Golf Centre -

A proposal to build an elderly care community had been put to the Parish Council about two years ago. This proposal has surfaced again as a pre -application submission. Indeed a presentation is being given to Hulcott

Parish Council at the same time as this meeting. It would seem that one reason for the resurfacing of this proposal is that there have been decisions in the High Court allowing Driving Ranges to be considered as Brown Field Sites and therefore preferred to Green Field Sites for development.

The proposal would result in more traffic coming on to the A418 near the future junction to Kingsbrook. The problem of the remoteness of the site and the lack of nearby amenities apart from those on site would still remain.

e) Great Lane Allotments - The ownership of the land has changed hands. All the current allotment holders have been given one year's notice. The current intention of the new owner is apparently to keep the land as allotments, to re-jig the plots and put water on site. The allotment holders will then be given first refusal on the new plots.

10. Neighbourhood Plan

The plan is progressing quite well with two launch dates being arranged to lead to a questionnaire being developed. Cllr Gilpin has hopefully been awarded funding from the government. The Parish Council agreed to spend £300 on display boards for the Neighbourhood Plan Events.

11. Jubilee Hall

Confirmation is being awaited from the Land Registry that the Jubilee Hall has been transferred from the current trustees to the four trustees put forward by the Parish Council. The Insurance on the Jubilee Hall is due to be renewed at the end of September and the available funds are in the current bank account to which the current trustees and Sandra White are the signatories. In view of this the Insurance will be renewed by the current trustees with the present Insurers. Cllr Sherley is looking at the procedure for changing the signatories on the bank account.

12. Website / Facebook

Facebook and Twitter are up and running with Cllr Cotton & Cllr Grieves as administrators. Cllr Grieves is to look at the structure of the Website.

13. Bierton Sports Centre & Recreation Ground

The Parish Council agreed with the proposal to install an additional dog bin at the far gate of the Recreation Ground.
