MINUTES OF PARISH COUNCIL MEETING HELD ON MONDAY 18th JUNE 2018 at 7.30 p.m.at the Jubilee Hall, Aylesbury Road, Bierton

2. Declarations of Interest

No interests were declared

3. Minutes of the Last Meeting

The minutes of the Parish Council meeting held on the 21st May 2018 were discussed and the following amendments made: -

- 13. Burcott Road was changed to Burcott Lane
- 14 a). The last sentence was amended to read It is hoped that this committee will encourage residents to stand as candidates for the proposed Kingsbrook Ward next year, *if approved by AVDC*.
- 14 c) The words 'to set up a committee for the Kingsbrook development' were deleted

The amended minutes were accepted as a true record and duly signed by the Chair.

4. Public Forum

The resident stated that he was concerned about the number of water leaks that had occurred in the village recently. The Parish Council advised that this issue was on the agenda and it was agreed to bring this item forward.

5. Water Leaks

The Parish Council was concerned over the number of water leaks that have occurred at different places in the village recently. Thames Water had been contacted and the problem is that the village is served by archaic metal pipes that need replacing. Thames Water is looking at replacing these pipes in the near future.

7. Planning Applications

The Parish Council agreed to OPPOSE Planning Application No 18/01957/APP for the following reasons: -

- a) The Parish Council is concerned over the change in the roof design. The Parish Council is somewhat surprised that a design that was put forward and approved by the Crematorium committee has suddenly become "too complex to build" and the Parish Council wonders about the reasons for the change.
- b) The Parish Council is concerned over the proposal that an integrated brick storage facility be replaced with a shipping container. The Parish Council considers that this change would hardly seem to

be in keeping with the rural setting and landscape.

The Parish Council would wish to speak at the Committee if the application is considered by Committee.

A meeting has been arranged for Tuesday 26th June at the Jubilee Hall.

10. Neighbourhood Plan

The Steering Group is looking at various Neighbourhood Plans online including Weston Turville, Thame and one in Derbyshire and is hoping to agree a method of putting together a draft proposal.

11. Events Planning Committee

The Events Committee reported that the outside of the Jubilee Hall had been decorated and that the costs had come in under budget.

Bierton with Broughton Running Festival is planned for Sunday 8th July with a 1K, 5K & 10K walk starting at 9 a.m. The committee has still to finalise issues regarding the supervising of the event on the day.

There has been much discussion regarding the film to be shown on the 8th and 9th September.

Paddington 2 is a probability. A deposit of £125 has been paid to Stargazing Outdoor Cinema to secure the dates.

Another litter pick is to be arranged for the 14th or 15th July.

The committee has agreed to concentrate on these events for the time being and has not yet looked at any other future events.

12. Community Assets

- a) Broadband at Sports Centre and Jubilee Hall The Parish Council agreed to have a phone line and broadband installed at the Sports Centre and Jubilee Hall. The contract with XLN will be for two years at a cost of £ 18.95 per month plus VAT for the first twelve months and £26.95 plus VAT for the remainder. The Parish Council did consider whether to add an inclusive call package to the Jubilee Hall for the Parish Clerk at an additional cost of £1 per month during the first twelve months but then £10 for the remaining twelve months. It was thought that the Parish Clerk could use a mobile at the office and therefore this was not thought to be necessary.
 - There will be an installation charge of £48 plus VAT per site and a £9.99 delivery charge of a router to both sites.
- b) Gas & Electric Contracts The Parish Council agreed to go with the recommendations from LSI energy to enter into 36-month contracts to ensure price stability for the next three years in a market that has shown a general upwards trend for the past few years. As a result of tendering the business to a number of National Suppliers, Scottish and Southern Energy has continued to produce the best prices in the current market along with Simple Gas Power for the supply of gas to the Sports Centre.
- c) Jubilee Hall Office It was agreed that the Parish Clerk will source a desk and chair for the office at an approximate cost of £200 and a laptop up to the value of £300.
- d) Great Lane Allotments There has been no update regarding the offer put forward by the Parish Council.

- e) Burcott Lane Layby Cllr Sherley will look at various grants.
- f) Car Parking Cllr Cotton has approached Vicky Bell about the possible use of a field near St Osyth's Well.

13. General Data Protection Regulation

This item was deferred to the next meeting. The clerk will circulate amended copies of the Privacy Notice and the Letter of Consent to the Parish Councillors and ask for feedback.
