MINUTES OF PARISH COUNCIL MEETING HELD ON 16th JANUARY 2017 at 7.30 p.m.

Present: Cllr. B. Robson in the chair, Cllr G. Sherley, Cllr S. Cotton, Cllr B. Dewis, Cllr H. Money, Cllr A. Webber and the Clerk Mrs. M. Smith in attendance.

3. Minutes of the Last Meeting:

Two amendments to the minutes of the Parish Council meeting held on the 21st November 2016 were made as follows:-

8b) Land at William Hill Drive - The application reference number should read 15/03541/AOP The following sentence was amended to read :-

The Parish Council noted that the appeal against refusal of the first application had been rejected.

The minutes were then accepted as a true record and duly signed by the chairman.

4. Public Forum

A resident stated that due to the fact that the Parish Council had not registered to speak in time at the Development Management Committee on Thursday 12th January on Planning Application No 16/03816/APP Land Adj Grove Court the item had been removed from the agenda and therefore she had been deprived of the opportunity to speak at the meeting and put forward her objections. District Councillor Ward has asked for an investigation into the software relating to registration process and is also looking into various deficiencies with the planning system at AVDC.

There were also some Broughton residents present who wished to raise the subject of the approval of Planning application No 15/03806/AOP Land North Of Aston Clinton Road (Former Aston Clinton MDA Site) and the subsequent application to the Secretary of State to call it in which was declined. The residents wished to thank the Parish Council for the support in objecting to this application. However they did want to know if there was anything else that could be done to change the decision of the access onto Broughton Lane.

Cllr Robson explained that the only avenue left was to apply for a judicial review. This would mean going to the High Court and proving that AVDC had acted unfairly and not followed procedure and this would be both costly and in this case difficult to prove.

Cllr Robson went on to state that the Hampden Fields Action Group has some interest as the former MDA site impinges and interacts with two other developments one in Aston Clinton and one in Weston Turville.

The residents also once again raised their concerns about Heavy Goods Vehicles using Broughton Lane and going over the canal bridge. Apparently the bridge has been knocked and is becoming cracked.

Cllr Robson also stated that Bucks County Council had not yet decided whether to use Broughton Lane as an access for Works Traffic.

Finally a resident made the Parish Council aware of blocked drains along the Aylesbury Road and possibly the main sewers. An engineer was due to make an investigation of the problem.

5. Clerks Report – The Clerk's report was noted.

6. Planning Applications

The following applications were considered:-

15/03374/AOP - Land off Barnett Way - Amended Proposals/Plans

Outline planning application with access to be considered and all other matters reserved for residential development of up to 44 dwellings including vehicular access, pedestrian and cycle links, public open space, landscaping, drainage & associated works. - The Parish Council did not have any further comments to make on this application further to the comments submitted on the 21st December (which referred to comments made on the 11th November 2015).

16/04113/APP 106 Aylesbury Road HP22 5DL Removal of two outbuildings to the rear. Conversion of existing dwelling into two dwellings with single storey front extension and dropped kerb. The Parish Council had no objections to this application but wished to note that the works " must respect the Conservation Area"

16/04142/APP Land to West of Rowsham Road - Outline Application with access to be considered and all other matters reserved for the erection of five detached dwellings with access parking and amenity space.

The Parish Council agreed to OPPOSE this application and it was agreed that Cllr Sherley would draft the comments in opposition to be submitted by the clerk by the 19th January. It was also agreed that the Parish Council would speak at the Committee meeting if the application is considered by committee.

16/04472/APP 10 Rowsham Road HP22 5DZ Demolition of existing single storey rear extension, two storey rear extension and refurbishment of existing dwelling. Amendment to approval no 16/02444/APP The Parish Council had no objections to this planning application.

16/04613/APP 94 Aylesbury Road HP22 5DL Erection of two detached dwelling homes with integral garages including formation of new access off Barnett Way.

The Parish Council agreed to OPPOSE this application and it was agreed that Cllr Cotton would draft the comments in opposition to be submitted by the clerk by the 31st January. It was also agreed that the Parish Council would speak at the Committee meeting if the application is considered by committee.

16/04572/APP Land Adj to 194 Aylesbury Road Erection of one detached dwelling and garage The Parish Council had no objections to this planning application.

16/04594/APP Land Adj to Conkers Barn 178a Aylesbury Road HP22 5DT Erection of a three bedroom detached dwelling.

It was decided that Cllr Cotton would look into this application and draft a response which would be circulated for approval by the other councillors before being submitted to AVDC by 13th February.

8. Other Planning Matters

a) Kingsbrook - Land East of Aylesbury, Broughton Crossing.

Cllr Robson had sent out an e-mail to Rachel Carson to ask if Barratt Homes are giving a welcome pack to all the residents. He also asked Cllr Cotton to consider delivering the Village Diary to the households that had moved in on the estate.

A stakeholder meeting had been arranged for 24th January.

b) 16/03816/APP - Land Adj Grove Court - This item had been discussed during the Public Forum. The Parish Council noted that the application had been approved.

c) 16/00087/NONDET - Land to West of Rowsham Road Application no 16/01053/AOP

Cllr Sherley agreed to look at this application and the Parish Council's original comments to AVDC in Opposing the application and to send any further response to the Planning Inspectorate.

d) 15/03806/AOP - Land North of Aston Clinton Road

This item had been discussed during the Public Forum.

e) Vale of Aylesbury Local Plan (VALP)

The unmet need figures from both Wycombe and Chiltern/South Bucks have been reduced and AVDC is now working to a figure of 26,800 homes. This means that the strategy needs re-writing. Therefore the timetable for submission of the VALP has been pushed back by 8 weeks.

f) Aylesbury Garden Town

Aylesbury has been chosen by the government to become one of three garden towns which will see it receive more than half a million pounds initially to help improve the long-term plans for the town.

9. Neighbourhood Plan

Cllr Robson stated that it is absolutely vital to have a Neighbourhood Plan in position to direct the growth of development in the parish. Cllr Cotton agreed to contact Cllr Gilpin to receive an update.

10. The Future of Local Government in Bucks

The District Council is due to vote on whether to submit the business case for two new councils for Buckinghamshire to the Secretary of State for Communities and Local Government.
