MINUTES OF PARISH COUNCIL MEETING HELD ON 15th September 2014

Present: Cllr. Robson in the chair, Cllr. Miller, Cllr Batson, Cllr. Cotton, Cllr Gilpin Cllr Horne, Cllr. Sherley, Cllr. Vaughan, Cllr Webber and the Clerk Mrs. Smith in attendance.

Parishioners present - 7

1. Apologies for Absence: County Councillor Bill Chapple, District Councillor Julie Ward

2. Declarations of Interest:

Cllr Miller & Cllr Sherley declared interests in the planning applications relating to Rowsham Road and Cane End Lane. Cllr Cotton declared an interest in the decoration of the Sports Centre and Cllr Webber declared an interest in the item on the Great Lane Allotments.

3. Minutes of Last Meeting:

The minutes of the meeting held on Monday 21st July were read and the following amendments made :- a) 2014/32 9 a) the word 'had' was replaced with 'will seek to' to read Cllr Miller will seek to set up a meeting

- b) 2014/33 12 a) the word United was inserted to read Aylesbury United Football Club
- c) 2014/35 17 the Cllr was replaced with Alderman

Malcolm Ash had sent a few notes on the progress of the Wingrave to Aylesbury Cycleway stating that funding had been raised for the survey.

The minutes were then accepted as a true record and duly signed.

4. Public Forum

A Hulcott resident expressed concern on the proposed development on Cane End Lane as there seemed to be no consideration of the effect increased traffic would have on the residents of Rowsham Road. The application did not give an exact number of vehicles that would be using the site. The resident stated that a number of Rowsham Road residents would like to see the road blocked off thus putting an end to the problem of access to Cane End Lane. A petition of the residents had been presented to the G.A.L.A.F. and the County Council had expressed the willingness to look at blocking the road off with lockable bollards. The District Councillor and County Councillor both support this proposal.

A resident expressed his concern on the number of sites around Aylesbury and in particular Bierton that had been shown on the AVDC website after the Call for Sites process and that Bierton was in danger of becoming part of Aylesbury. The chairman explained that these were sites that could potentially be developed but had not yet had planning permission and agreed that the Parish Council wished for Bierton to retain the village status and would consider any development plan on this basis.

The resident also asked if the Speed Sign situated at the moment on Burcott Lane could provide data on the speed of traffic using Burcott Lane. Cllr Gilpin said that the data provided by the sign could be used to find out the times at which cars are speeding and then it might be possible to get the police to come and use a police camera at these times.

Finally the resident asked if a respectful note could be put in the Green Sheet addressed to residents who walk across the fields around Bierton to keep to pathways and to pick up their dog's mess.

5. Clerks Report – The Clerk's report was noted.

6. Planning Applications

The following applications received via AVDC were considered:-

14/02162/APP - 65 Aylesbury Road, Bierton, HP22 5BS -Two storey side/rear, single storey side and single storey rear extension- **No Objections**

14/02315/APP - Land to East of Gib Lane, Bierton

Installation of ground based photovoltaic solar farm including access, associated works and grid connection.

The location chosen for a solar farm is not crossed by any footpaths and is enclosed by hedges and trees. There had been no response from the residents of Gib Lane. Hulcott Parish had supported the application.

The Parish Council resolved to **support** the application with the comments that this is a Green Scheme providing energy to a wider community. The location is situated away from residential properties and surrounded by hedges and trees.

14/02413/APP - 39 Parsons Lane, Bierton, HP22 5DF -Single storey rear extension & bow window to front- **No Objections**

14/02420/APP - 195 Aylesbury Road, Bierton, HP22 5DS -Rear Conservatory- No Objections

14/02472/APP - Old Mill House, Broughton Lane, HP22 5AW -Demolition of existing garage and workshop and erection of single and two storey side extension including alteration to existing access.

The Parish Council resolved to **support** this application with the comments that the Parish Council believes that this application has addressed the issues raised by the planning officer in refusing the previous application 14/00173/APP and that the proposed extensions would not affect the relationship between the Old Mill House and the adjoining property The Mill.

14/02564/ATC - 97 Aylesbury Road, Bierton, HP22 5BT -Reduce crown of one cedar- No Objections

14/02417/APP - Canal Basin, Stocklake Bierton - Erection of 42 dwellings with garaging & parking and associated works including vehicular and pedestrian access, estate roads and highway works, landscaping, open space, drainage infrastructure and works to the canal bank- **No Objections**

14/02532/APP - The Paddocks Business Centre, Cane End Lane, Bierton HP22 5BH - Change of Use of premises to vehicle storage and maintenance depot including alterations to existing access.

The Parish Council referred to the earlier discussion during the public forum and stated that there needed to be a better transport assessment of the application and a better indication of the envisaged traffic routine and timetable.

The Parish Council agreed to **oppose** the application with comments on the lack of information provided on the hours of work and future potential development, and on the extent of the increase in traffic which would affect the residents of Rowsham Road in the absence of the separation of Cane End Lane and Rowsham Road.

Cllr Miller agreed to work on a draft response which he would then circulate for approval before submission.

8. Other Planning Matters

a) Land East of Aylesbury (Kingsbrook)

There had been a meeting of some of the councillors with Barratt Homes on the 29th August to talk about the programme of development and the way ahead. It is likely that an application will be placed for the proposed roads and junctions by November to go before committee in February or March 2015. It is planned that work will start in November of next year with the roads being completed within 5 years of the work starting. The plan is to build 120 to 150 dwellings a year.

Barratt Homes are proposing to have a Public Exhibition in October. It has also been agreed to set up an Ecology sub-group and therefore anyone interested in becoming part of this group should be put in touch with Barratt's.

Cllr Gilpin expressed a concern about the financing of the development. The chairman asked Cllr Gilpin to draft a letter setting out his concerns and the chairman could then raise this issue with the County Councillor or the Chief Executive.

It was suggested that the Parish Council should get the first houses that are built on the development to be recognised as part of Bierton Parish and therefore be able to lay claim to some of the S106 monies. The chairman will explore this avenue.

- b) 14/01125/APP Land To North Of Cane End Lane Single Chapel Crematorium- including Minor Amended Plans. A Great Crested Survey had been submitted to AVDC.
- c) The proposal from AVDC advising a change to the Planning Bulletin from paper to electronic format and to only provide paper copies of major applications.

This decision had been made by officers and endorsed by members with limited consultation with the Parish Councils.

It was agreed that the clerk would forward the weekly bulletin to Cllr Robson and Cllr Miller.

Cllr Vaughan left the meeting at 9.30 p.m.

The problem with planning applications is that there is no Wi-Fi connection in the Jubilee Hall, therefore the applications would need to be downloaded onto a lap-top by the clerk to be brought to Council Meetings. This would mean an increase in the clerk's time and also some difficulty had been experienced in downloading some documents.

It was suggested that the clerk should e-mail the comment sheet received from AVDC to all councillors so that they could look at the application on-line, download the application to a lap-top and note any difficulties in so doing and only print off the papers if the application appears to be controversial. It would seem therefore that some of the cost savings that AVDC would make would be transferred to Parish Councils.

Another suggestion was to look at purchasing a laptop, projector and screen so that plans could be shown at parish council meetings in more detail and it was wondered if AVDC could bulk buy these items and then sell them to the parishes.

d) The Vale of Aylesbury Local Plan including The Call for Sites and attendance at Parish & Town Council Forum Thursday 16th October 6.30 p.m.

AVDC have recently undergone a Call for Sites as part of the process of getting a new local plan endorsed by the government. There is no mechanism in the process for the Parish Council to put in comments regarding the potential sites for development.

AVDC is forecasting that The Vale of Aylesbury Local Plan (VALP) will be endorsed in 2017. In the meantime there is no local plan in place which has lead to the comparatively large number of sites that are currently under appeal.

e) Aylesbury Eastern Link Road

Buckinghamshire County Council has recently tabled a motion to make a decision regarding the acquisition of land for an link road from the Kingsbrook development to the Aston Clinton roundabout on the A41.

f) Great Lane Allotments

The Parish Council were informed that there is a possibility that the land may be sold for development.

9. Council Devolution Programme

Cllr Cotton reported on the meeting with Keith Gray from Aylesbury Town Council on 9th September. The council proposed to take on the grass cutting in the parish (as well as a number of other parishes) from Bucks County Council and to do 8 cuts possibly 10 cuts during the growing season to include both sides of Rowsham Road and the 30 to 40 mph section in Broughton. Also the Town Council said if the Parish Council advised them about the hedges that had not been cut then the Town Council would write to the owners. There is still a query over whether the Town Council would take on the other services that were being devolved to the parish. It is the intention of the Town Council to take on the Grass Cutting and possibly the other services over a two year trial period.

A query was also raised as to whether the council would need to get three quotes in order to comply with financial regulations or whether the contract would pass from Bucks County Council to Aylesbury Town Council.

10. Sports Centre & Recreation Ground

The Sports Centre Management Committee proposed that the rest of the interior of the Sports Centre is redecorated over the Christmas period. The referee's room and the changing rooms had been decorated over the summer leaving the main hall, corridor and toilets to be done. A quote of £ 2,000 including materials had been obtained from D. Hargrove.

The Parish Council resolved to accept this quote.

Cllr Cotton also advised the Parish Council that she had asked John O'Connor to mark out the football pitch once the new goalposts had been erected.

The committee also informed the council of the proposal to purchase a line marking machine so that the football teams could take on the job of marking the lines in the future.

The Parish Council agreed in principle to this proposal.

11. Temporary Speed Indicator Device (TSID) Sign

Cllr Gilpin gave an update on the position regarding the replacement sign. He said that CA Traffic were having difficulties in getting parts but he had been promised that the new sign would be ready at the end of October.

He was also looking at what could be done from the data collected and whether it could be sent to Bucks County Council and the police.

15. Matters of Report

- a) 72 Aylesbury Road The clerk was asked to send a letter to the owners to ask that the overhanging hedges of the property were cut back close to the boundary and the height reduced. Also the tree on the corner of Great Lane and Aylesbury Road.
