- Bierton Events Group
- Gate to front door on 26th June, Calendar competition have received several entries to date, run planned for November and plans for a cinema & Santa sleigh are underway. The group are also thinking of ideas for Jubilee celebrations in 2022
- Jubilee Hall & Sports Centre/Playground
 - Rospa report received and few minor points raised.
 - After discussion, it was resolved to now stop the weekly spraying of disinfectant at the playground, Covid signage will remain in place.
 - Several bookings have had to be cancelled due to the delay in the restrictions being lifted.
 - Pavilion Plaque contract received, Clerk to sign and work is planned for August.

- Highways/Footpaths
 - ELR is unofficially open, official opening is planned for end of July.
 - The hedgerow at Barnett Way has been cleared.
 - Drainage Gulleys are currently being cleared.
 - E-Scooters Parking area has been suggested, at the end of the layby on the A418, the parish
 council discussed this proposed site and are concerned by the proximity to the main road and
 feel its too dangerous and would like clarification of why this site has been chosen by Zipps
 and the Transport team. Cllr Knowles to feedback the concerns.
 - Around Bierton Walk The newly rerouted Bierton Walk has been designed and leaflets have been produced detailing the new route. Way markers have also been ordered and are due to be installed in the near future.

Cllr Dewis asked could stile at the allotments/towards Barnet Way be replaced with a gate – Cllr Fisher will look into this.

Cllr Webber raised the hedge on Great Lane as it is overhanging the footpath.

Cllr Fisher reported that a parishioner would like to formalise a current "well todden path" behind the Great lane allotments and has asked for local support by those that use it.

Cllr Knowles reported back regarding the concerns raised a while ago about the footpath that runs along the dairy, the response from the rights of way officer from Buckinghamshire Council has been very disappointing as they do not share the same concerns. Cllr Knowles is to request a site meeting with Buckinghamshire Council to further assess.

Cllr King reported back that a facebook community page for The Coppice, Bierton Park & Oldhams Meadow has been created.
